## LEASE CONDITIONS - EARLY TERMINATION

This Lease Conditions Form outlines the financial and legal obligations associated with submitting a 30-Day Notice to Vacate prior to the expiration of the lease term. Submitting a 30-day notice does NOT terminate or cancel an active lease agreement.

### 1. Lease Term Obligations:

- A 30-day notice does not release the tenant from the contracted lease term.
- Tenant remains fully responsible for rent, utilities, and all lease terms until the lease expires OR until a qualified replacement tenant begins paying rent—whichever occurs first.

### 2. Rent Responsibility:

- Tenant must continue paying rent through the end of the lease term, regardless of when they vacate.
- If a new tenant is secured early, rent will be prorated accordingly and responsibility will transfer once the new tenant's lease begins.

### 3. Re-Rental & Showing Requirements:

- Property must be made reasonably available for showings with proper notice.
- Tenant must maintain the property in clean, show-ready condition during the re-rental period.
- Denial of showings may delay re-rental and extend the tenant's financial responsibility.

### 4. Move-Out Requirements:

- Tenant must follow the move-out guidelines outlined in the lease agreement.
- Professional carpet cleaning is required with a valid receipt provided upon key return.

### 5. Keys & Forwarding Address:

- All keys, remotes, and access devices must be returned to Intero Property Management.
- A forwarding address must be provided for the security deposit return and final accounting.

### 6. Security Deposit Processing:

- Nevada law allows 30 days for Intero to process the deposit and provide an itemized list of deductions.
- Deductions may include unpaid rent, damages, cleaning, missing items, or lease violations.

### 7. Acknowledgment:

By signing below, the tenant acknowledges that they understand and agree to the conditions listed above and that a 30-day notice does not cancel, void, or terminate an active lease agreement.
